

Implementing Regulations for Non-Governmental facilities for people with disabilities

Article 1:

- 1. The terms and expressions defined in Article 1 of the regulation on non-governmental social facilities for people with disabilities, issued by the Council of Ministers Decision No. (691) of 17/8/1445 H (27/2/2024), shall, whenever referenced in these Rules, retain the same meanings as specified in the regulation, unless otherwise indicated by the context.
- 2. The following terms, whenever mentioned in these Rules, shall have the meanings assigned herein unless the context otherwise requires:

Rules: The Implementing regulations governing non-governmental facilities for people with disabilities.

Guide: A comprehensive reference document outlining detailed requirements and procedures, issued in accordance with the these rules, as stipulated in Article 15 thereof.

Section: A designated unit within a social facility that provides social services to people with disabilities, classified by age group, category or gender.

Article 2:

First: Specialized facilities licensed by the Ministry to offer social programs for people with disabilities are classified as follows:

- 1. Daily social welfare facilities shall be categorized as follows:
 - a) Classification by gender and age group:

- 2. Residential and social welfare facilities.
 - a) Services shall be provided by female staff to children (male and female) up to the age of 12 years.
 - b) Services shall be provided by female staff to female beneficiaries over the age of 12.
 - c) Services shall be provided by male staff to male beneficiaries over the age of 12.
- 3. Social-housing facilities, which provide separate sections based on beneficiary's gender and age group, as shown in the table below.

4. Multiple social facilities that offer more than one social program within a single headquarter.

Second: Facilities that engage in activities not exclusively targeted at people with disabilities and are licensed by the Ministry to conduct social program activities shall be classified as follows:

- 1. Educational facilities licensed by the Ministry of Education, namely:
 - a) Schools.
 - b) Training centers.
 - c) Boarding schools.
- 2. Health facilities licensed by the Ministry of Health:
 - a) Medical rehabilitation centers.
 - b) Long-term care hospitals.
 - c) Mental health centers.

Third: With respect to daily social welfare facilities referenced in paragraph (1) of section I of this Article, the following provisions shall apply:

- 1. Facilities shall specialize in a single age group but may accommodate multiple age groups, provided that separate sections are established for each age group.
- 2. Facilities may support multiple categories of disabilities, provided that specialized training classes are established for each type of disability (Auditory visual kinetic intellectual).

Fourth: Concerning Social-housing facilities referenced in paragraph (3) of section I of this Article, the following provisions shall apply:

- 1. A Social-housing facility may specialize in a single age group, by gender of beneficiaries, by type of disability, or may operate as a general facility.
- 2. The maximum number of residents per room shall not exceed two persons.
- 3. Each building within the facility may accommodate no more than 25 persons with disabilities, with the option of maintaining multiple separate building.
- 4. Appropriate accommodations shall be provided to enable people with disabilities to maintain autonomy within the residence, in accordance with the specifications set forth in the guide.

Article 3:

A facility seeking to obtain a license shall comply with the following requirements:

First: Submit a license application indicating the type of the facility according to the classification set forth in Article 2 of these rules.

Second: Meet the licensing requirements as follows:

1. Licensee requirements:

3. Requirements for technical and administrative cadres according to the type of facility:

- 4. An accredited certification must be obtained for social programs provided according to facility types from the Ministry's General Administration for the Support and Empowerment of People with disabilities. Certification must aligh with the regulation on social and vocational programs for people with disabilities and its implementing regulations, as issued by Council of Ministers Decision No. 691 of 17/8/1445 H (27/2/2024).
- 5. Financial compensation performance.

Article 4:

- 1. The facility is prohibited from providing any service prior to obtaining a valid license.
- 2. A facility seeking to offer additional services and programs shall obtain the necessary licenses from the competent authority and submit these to the general management of licensing prior to providing the service.

Article 5:

The license shall be valid for a period of five years.

Article 6:

License renewal requires the following:

- 1. Submission of a license renewal application no later than 180 days prior to the expiration of the current license period.
- 2. Compliance with all requirements specified in the Guide.
- 3. Fines shall be paid (if applicable).
- 4. Payment of any required fees.

Article 7:

A facility seeking to amend an issued license must:

- I. Submit an application specifying the type of amendment; including any of the following: transfer of ownership, relocation of headquarter, reclassification (per the classifications outlined in Article 2 of these Rules), change in activity, addition of an activity, or the modification of facility capacity.
- 2. Compliance with all requirements specified in the Guide.
- 3. Fines shall be paid (if applicable).
- 4. Payment of any required fees.

Article 8:

Without prejudice to the provisions of these Regulations and other statutory provisions, the facility must notify the general management of licensing of any changes made to the licensed facility.

Article 9:

The facility shall inform people with disabilities, benefiting from its services or their guardians (as applicable), of any modification to its license and its fulfilment of obligations to them. The facility must also notify the general management of licensing of fulfilling these obligations at least 90 days prior to the amendment.

Article 10:

- 1. The license shall be revoked under the following circumstances:
 - a) Upon submission of an application by the facility requesting license revocation.
 - b) In the event of the licensee's death.
 - c) Upon issuance of a penalty resulting in license revocation.
 - d) If the licensee no longer meets one or more of the licensing conditions.
- 2. For voluntary cancellations as provided for in this Article (10) paragraph (1) Clause (A), the following conditions must be met by the facility prior to revocation:
 - a) Payment of any outstanding fines, if applicable.
 - b) Provision of evidence demonstrating that beneficiaries have been informed of the revocation.
 - c) Provision of evidence confirming fulfillment of all obligations to the beneficiaries.

Article 11:

First: Pricing for social programs offered by the facility as well as any future adjustment to these prices, shall be determined based on the following criteria:

- 1. Social programs must be certified in accordance with Article (3) paragraph (4) of the Rules.
- 2. Qualifications and expertise of the facility's staff.
- 3. Quality and level of the facility's infrastructure.
- 4. Quality standards of social programs offered, as demonstrated by certified quality certificates.

Second: In all cases, the facility must publicly display the Ministry-approved price list before providing any services to beneficiaries.

Article 12:

The facility shall adhere to the following requirements prior to promoting any activities related to the facility or to the people with disabilities benefiting from its services:

- 1. The promoted activity must be certified in accordance with Article (3) paragraph (4) of the Rules.
- 2. Written consent must be obtained from the people with disabilities, or from their guardian (if applicable), in the event of involving them in any promotional announcement.

Article 13:

The Guide specifies the monitoring mechanism of the Ministry-licensed facilities to verify their compliance to the implementation of the Regulations and Rules. In particular, the Guide outlines the monitoring procedures for the following:

- 1. Adherence to licensing requirements.
- 2. Adherence to the requirements of social programs.

Article 14:

The table below outlines the official operating hours for specialized facilities that provide social programs for people with disabilities, as well as the duration for implementing approved social programs.

Article 15:

The Rehabilitation and Social Guidance Agency shall prepare a procedural guide encompassing all necessary provisions for the implementation of the Rules, to be ratified by a decision of the Minister.

Article 16:

Any provisions conflicting with the rules shall be repealed.
